




CACFP had 37 providers submit claims for December. I think that the numbers below are interesting in the fact that 1 year ago I had the same number of providers, yet the meal counts are higher this year. One of the things that I attribute this to is that I currently have 6 providers that have applied for through HHS and received Exception to Policy waivers. These waivers allow providers to care for additional children over and above the maximum capacity of their license.

My numbers are getting so low that I am monitoring my budget very closely and will continue to do so.

- Liheap (Low Income Household Energy Assistance Program) starts Oct. 1<sup>st</sup> for a household with an elderly (60 years of age or older) and/or a disabled household member. Also, any household in a crisis related situation may apply for Liheap in October. Everyone else can apply Nov. 1<sup>st</sup> thru April 30<sup>th</sup>.
- LIHEAP APPLICATIONS: For December, Outreach took and processed 646 Liheap applications.
  - 31 applications were denied.
  - 5 online applications.
- YTD TOTALS: From 10-01-2024 to 12-31-2024: Total Liheap applications processed 3,106.
- **CRISIS:** For December, 10 households received ECIP-Crisis funds in the amount of \$3,717.55.
- At this time, we are not assisting with crisis for Service Continuity, due to applicants are protected from being disconnected from the Moratorium. Also, have not assisted with furnace repair/replacement crisis for homeowners due to the new State System and available funding. Will see later if able to assist with this or not.
- We are working on a new State Liheap System.

We are working on our regular contract called Liheap-24 Crisis contract.

### Annual Point-In-Time Count also known as PIT Count

In order to gain a better understanding of homelessness in our communities, our staff will be conducting a census of the homeless population called a Point in Time Count as required annually by the Department of Housing and Urban Development. Upper Des Moines Opportunity, Inc. (UDMO) is the Designated Lead Agency for the annual Point-In-Time Count covering 12 counties in Iowa: Dickinson, Emmet, Clay, Palo Alto, Buena Vista, Pocahontas, Humboldt, Wright, Sac, Calhoun, Webster and Hamilton. We will travel through the region on January 29<sup>th</sup> and 30th, looking for any individuals that appear to be homeless (such as in cars, tents, parks, on the streets, etc.). The data collected affects Iowa's funding allocations from the department of Housing and Urban Development (HUD).

On January 29<sup>th</sup> or 30<sup>th</sup> if you notice, encounter, or are aware of any homeless individuals within our service region, please contact me, at 515-269-7105 to report the number of homeless individuals. If this is a person you have interacted with, please urge them to call me directly. Observational data including the person's name, gender, age, race and county is helpful, but not required.

It's important to note that to be included in the count individuals must meet the definition of <u>literally homeless</u> which means the person slept in a place not meant for human habitation on the night of January 29th. (Car, streets, tents, outdoors, homeless shelters, shelter with no heat or electricity, park bench, barn, etc.) We cannot count those who sleep on a friend's couch.

### **Staff/Client Success Stories**

I met up with a middle-aged man who had been living in his truck for a month or so. One night while sleeping in his truck the vehicle started on fire (electrical). All his worldly possessions were destroyed. Within a few days we had secured a one-bedroom apartment. We furnished it with a donation/voucher from a thrift store in Spencer. He was able to get some clothing as well. With our help he was able to replace his social security card, ID and apply for SNAP and Housing. After moving into his apartment, he got to know the manager, she put him to work doing small maintenance projects. This built his self-esteem and gave him a little money.

The client is now working on getting social security disability with the help of a local attorney specializing in disability.

Statewide Crisis Line Update: Clients in need of rental assistance should call the Statewide Crisis Line at 1-833-739-0065 to complete the intake process. Normal business hours are 7am – 8pm. Clients calling outside of these hours will need to leave a message and wait for a call back. Call backs are being made within 24-48 hours.

### **Weatherization Update:**

The Weatherization Department for the month of December was another great month we completed another 10 homes and a grand total of 118 homes exceeding our goal for the year. Not much to talk about for the month of December besides that starting in 2025 we will be getting our new contracts and I will send those dollar amounts in the next month's report. We will also be starting our flat rate pricing on January 17<sup>th</sup> 2025 for insulation contractors ONLY to see if that helps with material and labor cost on our client's home. This is a new requirement that the DOE (Department of Energy.) So, we will be starting this soon and we will see at the end of the year how this is beneficial or not with budgets moving forward.

Until then we will continue to push hard and create results and effectively assist our clients with their energy needs on their homes in our 17-county area that we serve.
